Dear Rachael

Thank you for the information request received by the Council on Wednesday 22 May regarding the farewell function for interim Chief Executive Stephen Parry. You asked for:

All council costs associated with Stephen Parry's farewell on May 17, including invoices, and all correspondence, including emails, texts and WhatsApp messages regarding the event.

The Council provides the following response:

Attached is all correspondence and invoices regarding the interim Chief Executive's farewell function. Some information has been redacted in accordance with Section 7 (2)(a) – to protect people's privacy.

The function was to mark Mr Parry's 23 years of service to the Gore community and Council.

The total cost of a gift for Mr Parry was \$1,300. However, only \$500 was paid by the Council, in keeping with our Sensitive Expenditure Policy. This policy states the Council's contribution to a staff member leaving after 10 years of service would be \$250.

Elected members decided a \$500 contribution would be appropriate given Steve's employment was more than 20 years.

The remainder of the gift's cost was covered by contributions from staff. Total costs to the Council for the function were:

- Catering: \$1,489.25. Number of people catered for was 70.
- Grazing tables, fruit juice and soft drink: \$617.77
- Gift: \$500
- Room hire: \$420

The limited alcohol provided at the function was paid for by elected members in their private capacity.

If you are unsatisfied with the response, you are entitled to lodge a complaint with the Office of the Ombudsmen. You can find more information on its website

i Steve, by the time this is read out, I'll be cruising at about 36,000 feet in the air on my way home. I am really sorry not to be able to be at your farewell function, and thank Tracy for reading my notes out.

When your appointment was announced back in 2001, I have to admit there was a fair degree of apprehension amongst staff. As some will recall, it followed tumultuous and very public scraps between the previous Chief Executive and some of the elected members of that time. Some may say not too different to recent times.

Certainly from my perspective, that apprehension soon dissipated. As the second Chief Executive for the Gore District, you set about making a positive impact and implementing a lot of wide ranging and welcomed improvements. These included an expected standard of dress for the office staff (that was music to my ears), writing reports that included recommendations that had some meaning, unlike "a direction from the Council is sought" which was pretty much the standard fare offered at that time. Organisational values such as professionalism, serving the community and integrity were developed along with a code of ethics. Both of these documents, which were also woven into everyone's performance appraisals, have stood the organisation in very good stead. The introduction of annual appraisals for all staff, rather than a select few, was also welcomed by most. Of course, with any new broom, there had to be a few sweepings to sort out and there were a number of those in the early 2000s that ultimately benefitted and strengthened the organisation. Some were challenging, but in true Steve Parry fashion, determination and common sense prevailed and the Council was on a good track that lasted for a number of years. Yes, there were a few headlines that popped up from time to time and the bitter and twisted keyboard warriors have never seemed to diminish much, but you always stuck up for what you believed in and ultimately, what was best for the organisation.

I know from my time spent as a member of national local government working parties that what we had in Gore was very, very good. Talking with colleagues, Gore was in a good place and had a Chief Executive that was professional, interested, supportive and progressive. No-one ever thought Steve Parry was someone who sat on his laurels and let everyone around him do the work. You were a person who got stuck in and did the hard yards, taking remedial action and risks when necessary. The standards demanded were not unreasonable. You refused to accept sloppiness on any front. Many reports were returned to authors with changes. The unfortunate thing with that was that most never picked up on the nuances of improvement suggested and kept making the same mistakes. The old saying "you can lead a horse to water, but can't make it drink" still rings true.

Over the past 23 years, there have been lots of good times interspersed with a few dark times. These mainly centred around staff who held a grudge for wrongly claiming they had been bullied into leaving the Council when in reality, they were simply not up to what they were expected to do. Some of these people sided with the few misguided members of the "we know best" group who are still active today. Some of the accusations made beggared belief and in the end, the action taken by you resulted in the best outcome. Some of these will be the same people who think Steve is a hard, unsympathetic person. I know that is completely untrue. Steve is a person who has a sensitive and caring side to him and I have seen that displayed many times.

We have always had lots of great discussions that might start with an analysis of the previous night's meeting and end up on a completely different topic. You always had an open door and willing to have a yarn at any time. You were the voice of reason at many meetings. Your ability to think off the cuff and create sense out of an issue that was going down a rabbit hole was unique.

As Cr Reid pointed out at the last Council meeting, there have been a number of highways to hell in recent months, but your professionalism always shone through. When it would have been so easy to have thrown in the towel, your resilience, personal beliefs and wanting to do the right thing kept you going, and I have admired you for that.

From my personal point of view Steve, it has been a blast and an absolute pleasure and privilege to have worked with you over the past 23 years. Thank you for your service to the Council and the community. You can and should be enormously proud of what you have achieved. Gore is certainly the better off for it, but it is the end of an era that will be a very hard act to follow.

My very best wishes to you on becoming "Joe average". I hope the next stage in your life will be rewarding and you get the chance to put your many skills to good use.

I look forward to a private catchup with you and Wendy in the near future.
